1. Introduction

The Dodd-Frank Wall Street Reform and Consumer Protection Act (Dodd-Frank Act) requires the CFPB to conduct certain market monitoring activities to fulfill the responsibilities imposed by the Act. In 2022, the CFPB proposed a rule to create a nonbank registry to assist the CFPB with market monitoring and supervision of certain nonbank covered persons.

The <u>Registry of Nonbank Covered Persons Subject to Certain Agency and Court Orders Final</u> <u>Rule (NBR Orders Final Rule)</u> was issued on June 3, 2024, requiring certain nonbank entities to register information about their company and certain agency or court orders, as well as submit copies of those orders, to the CFPB. The final rule, effective on September 16, 2024, provides that registration will begin as early as October 16, 2024.

The nonbank registration requirements are published in the <u>Nonbank Registration Regulation</u> (12 CFR 1092).

1.1 Purpose of this guide

The CFPB created a Nonbank Registry to accept certain types of data from covered nonbanks. This guide provides the filing instructions for registering with the Nonbank Registry, as discussed in 12 CFR § 1092.102(a) and is the definitive source of information for submitting data to the Nonbank Registry, as explained in the preamble of the NBR Orders Final Rule.

These resources may be useful for employees in a variety of roles, including compliance staff or vendors that help develop compliance systems. Some practical implementation considerations include:

- *Identifying affected institutions, products, departments, and staff.* If covered by the Nonbank Registration Regulation, entities will want to determine those affected within their entity. The effects on products, departments, or staff may vary greatly depending on institution size and the number of required registrations. This may include providing the appropriate staffing and training, as applicable.
- *Identifying changes to business processes, policies, and systems*. If covered by the Nonbank Registration Regulation, entities will want to determine what policies and procedures they must put in place to comply with the registration requirements, including identification of required registration information.

Identifying impacts to affiliates and business partners. Depending on an entity's business model, entities will want to identify whether the Nonbank Registration Regulation impacts their affiliate businesses or other business partners, and how best to coordinate to comply with the Nonbank Registration Regulation.

1.2 Use of examples

This guide uses examples to illustrate some portions of the Nonbank Registration Regulation requirements or data specifications. The examples do not include all possible factual situations that could illustrate a particular provision, trigger a particular obligation, or satisfy a particular requirement or instruction. Even though an example may identify a fictitious nonbank as, for example, "Company A," the provision or obligation being illustrated in the example may apply to all nonbanks, as defined in the Nonbank Registration Regulation.

2. Portal instructions and data entry specifications

Nonbanks can access and upload information to the Nonbank Registry through the "CFPB's NBR Portal." The CFPB's NBR Portal, as well as resources for submission, is available at <u>www.consumerfinance.gov/data-research/nbr-submission/</u>.

This section provides the data field entry specifications and instructions for all information required to be submitted to the CFPB's Nonbank Registry under the Regulation. The data field entry specifications are provided in the manner presented in the CFPB's NBR Portal.

Upon first registering a nonbank, a user must provide contact information for themselves, which will create a user account, and simultaneously provide the required Entity Registration Information. More information about the Entity Registration Information can be found in the Nonbank Registration of Orders Final Rule Executive Summary. After registering the nonbank, including creating the user account, the user will receive an automated email that includes the user's username and how the user can log in to the CFPB's NBR Portal.

Once logged in, the user will become a returning user and will be taken to the CFPB's NBR Portal Home page where they can manage and find:

- 1. Company and user information, including adding user accounts for the nonbank (Sections 2.3 and 2.4);
- 2. Order information to be registered (Section 2.5);
- 3. Notices submitted to the CFPB (Sections 2.4.2 and 2.5.3); and
- 4. Support and resource needs (Section 2.6).

Each of these steps and CFBP's NBR Portal sections is discussed in turn below.

The account creation process is a one-time process required for the first time any nonbank registers with the Nonbank Registry to submit information to the CFPB. The nonbank must identify a designated user to become the first authorized user for the nonbank. The user will select the "Register Your Company" button on the CFPB's NBR Portal Get Started page, which will allow the user to register the nonbank and register themselves as an authorized point of contact for the nonbank. A nonbank may only be registered once¹ with the CFPB's Nonbank Registry, but it may have several authorized users (including multiple points of contact users) that can submit information in the CFPB's NBR Portal on behalf of the nonbank. After a nonbank is registered with its first authorized point of contact user, all other business, including creating additional user accounts or updating the provided nonbank information, will be completed through the CFPB's NBR Portal Home Page (see Sections 2.2, 2.3, and 2.4 below).

Registering a nonbank requires a user to provide Company Point of Contact Information, Company Information, Company Principal Place of Business Address Information, and Company Unique Identifiers. Data specifications for this It is strongly recommended that the user obtain all the relevant and required information for the registering nonbank *prior* to creating the registration as the CFPB's NBR Portal does not provide an option to save and exit during registration.

¹ If a nonbank was previously registered and all authorized users have since left the nonbank, the nonbank will need contact NBR Help (NBRHelp@cfpb.gov) to add new authorized users.

formation is provided below. To submit a registration, some fields are required (or required when applicable) and are designated as such by a red asterisk (*) next to the field name. Some fields are required only if certain selections are made, and do not appear unless those dependent selections are made. Additional images are provided below to identify those fields. All required fields must be completed prior to clicking "Submit Registration."

2.1.1 Company Point of Contact Information

The Company Point of Contact Information section is where the registering nonbank's first user enters their contact information. Additional user accounts may be created in the CFPB's NBR Portal after the nonbank is successfully registered (see Section 2.3).

The registration form requires the point of contact to enter their first name, last name, and email address. The email address provided should be one the point of contact uses to send and receive correspondence related to the nonbank. The point of contact may also optionally provide their title.

FIELD 1: FIRST NAME (RULE SECTION: § 1092.201(A); 205(A)(2)) Instructions

- Information Type: Administrative
- Required: Yes
- *Instructions:* Enter, in the free form textbox, the first name of the designated point of contact registering the nonbank.

EXAMPLE: If the person's name is Jane Smith, enter "Jane"

Validations

- Must be 1 to 40 characters in length.
- May contain any combination of uppercase and lowercase letters (i.e., A-Z and a-z) and numbers (i.e., 1, 2, 3, etc.), spaces, or special characters (e.g., hyphen, apostrophe).

FIELD 2: LAST NAME (RULE SECTION: § 1092.201(A); 205(A)(2))

Instructions

- Information Type: Administrative
- Required: Yes
- *Instructions:* Enter, in the free form textbox, the last name of the designated point of contact registering the nonbank.

EXAMPLE: If the person's name is Jane Smith, enter "Smith"

Validations

- Must be 1 to 80 characters in length.
- May contain any combination of uppercase and lowercase letters (i.e., A-Z and a-z) and numbers (i.e., 1, 2, 3, etc.), spaces, or special characters (e.g., hyphen, apostrophe).

FIELD 3: EMAIL ADDRESS (RULE SECTION: § 1092.201(A); 205(A)(2)) Instructions

- *Information Type*: Administrative
- *Required*: Yes
- *Instructions:* Enter, in the free form textbox, the email address of the point of contact creating the registration for the nonbank. This should be the email address used by the point of contact to send/receive correspondence related to the nonbank.

Edits to the email address are restricted and may only be done by CFPB staff through submission of a Support Ticket (see Section 2.6).

Validations

- Must be name@example.com format.
- Must be 3 to 80 characters in length.
- Must not contain any spaces.
- May contain any combination of uppercase and lowercase letters (i.e., A-Z and a-z) and numbers (i.e., 1, 2, 3, etc.), or special characters (e.g., hyphen, apostrophe).
- The domain extension (characters provided after the period in an email address, such as .com or .org) must contain at least one character and the character must be a letter (i.e., A-Z and a-z), or number (i.e., 1, 2, 3, etc.).

FIELD 4: TITLE (RULE SECTION: § 1092.201(A); 205(A)(2))

Instructions

- *Information Type*: Administrative
- Required: No
- *Instructions:* Enter, in the free form textbox, the point of contact's title as designated by the registering nonbank (e.g., Chief Compliance Officer, Vice President).

Validations

- Must be 0 to 28 characters in length.
- May contain any combination of uppercase and lowercase letters (i.e., A-Z and a-z) and numbers (i.e., 1, 2, 3, etc.), spaces, or special characters (e.g., hyphen, apostrophe).

2.1.2 Company Information

The Company Information section provides fields to submit the registering nonbank's identifying and administrative company information. More information about the identifying and administrative company information can be found in the <u>Nonbank Registration of Orders</u> Final Rule Executive Summary.

FIELD 5: COMPANY LEGAL NAME (RULE SECTION: § 1092.201(G))

Instructions

- Information Type: Identifying
- Required: Yes
- *Instructions:* Enter, in the free form textbox, the full legal name of the registering nonbank (including any suffixes, e.g., "Inc." or "LLC").

Validations

- Must be 1 to 80 characters in length.
- May contain any combination of uppercase and lowercase letters (i.e., A-Z and a-z) and numbers (i.e., 1, 2, 3, etc.), spaces, or special characters (e.g., hyphen, apostrophe).

FIELD 6: DOING BUSINESS AS OR FICTITIOUS BUSINESS NAME (RULE SECTION: $\$ 1092.201(G)

Instructions

- Information Type: Identifying
- *Required*: Yes, if applicable
- *Instructions:* Enter, in the free form textbox, any names other than the legal name for the registering nonbank that have been used by the nonbank since January 1, 2017. If entering multiple names, each name must be separated by a semicolon.



EXAMPLE: To provide 3 doing business as names, enter, "Company A; A Co.; Company A, Inc."

Validations

- Must be 0 to 80 characters in length.
- May contain any combination of uppercase and lowercase letters (i.e., A-Z and a-z) and numbers (i.e., 1, 2, 3, etc.), spaces, or special characters (e.g., hyphen, apostrophe).

FIELD 7: CONSUMER FINANCIAL PRODUCT OR SERVICE TYPES LIST (RULE SECTION: §§ 1092.201(A); 205(A)(2))

Instructions

• *Information Type*: Administrative

- *Required*: No
- *Instructions:* Select all applicable type(s) of consumer financial products or services offered by the registering nonbank. If "Other" is selected, a free form textbox will appear that must be completed (see Field 7a discussion below).

Validations

• If "Other" is selected, Field 7a must be completed ("Other" Consumer Financial Product/Service Type Free Form Textbox).

FIELD 7A: "OTHER" CONSUMER FINANCIAL PRODUCT/SERVICE TYPE FREE FORM TEXTBOX (RULE SECTION: §§ 1092.201(A); 205(A)(2))

- *Information Type*: Administrative
- *Required*: Yes, if "Other" is selected in Field 7
- *Instructions:* Enter, in the free form textbox, the other financial products or services not available in the multi-select list in Field 7 offered by the registering nonbank. If entering more than one type of financial product or service, separate each type with a semicolon.

Validations

- Must be 1 to 1,000 characters in length.
- May contain any combination of uppercase and lowercase letters (i.e., A-Z and a-z) and numbers (i.e., 1, 2, 3, etc.), spaces, or special characters (e.g., hyphen, apostrophe).

FIELD 8: STATE/JURISDICTION OF INCORPORATION LIST (RULE SECTION: § 1092.201(G))

Instructions

- *Information Type*: Identifying
- *Required*: Yes, if Field 9 is *not* checked
- *Instructions:* Select, from the drop-down list, the applicable state or jurisdiction of incorporation or organization for the registering nonbank. The drop-down list values are the two-character abbreviation for each of the 50 states, District of Columbia, and the five US territories. If the jurisdiction of incorporation or organization is not listed, leave field 8 as "—None—" and select the checkbox "Jurisdiction of Incorporation or Organization (if not listed above)" in Field 9 (below).

Validations

• Must have one value selected if Field 9 checkbox is blank.

FIELD 9: STATE OF INCORPORATION OR ORGANIZATION NOT LISTED CHECKBOX (RULE SECTION: § 1092.201(G)

Instructions

- *Information Type*: Identifying
- *Required*: Yes, if there is no selection for Field 8

2.1.3 Company Principal Place of Business Address Information

The Company Principal Place of Business Address Information section is an additional section of required Entity Identifying Information to provide the registering nonbank's identifying principal place of business address information.

All address fields should be entered in the format required by the United States Postal Service.

FIELD 10: ADDRESS IS FOREIGN/INTERNATIONAL CHECKBOX (RULE SECTION: § 1092.201(G))

Instructions

- Information Type: Identifying
- *Required*: Yes, if principal place of business is a foreign/international address
- *Instructions:* Select the checkbox if the principal place of business address for the registering nonbank is located in a foreign country.

Validations

• Must not be selected if Fields 11 through 14 are completed.

Validations

- Must be 1 to 125 characters in length.
- May contain any combination of uppercase and lowercase letters (i.e., A-Z and a-z) and numbers (i.e., 1, 2, 3, etc.), spaces, or special characters (e.g., hyphen, apostrophe).
- Will not appear if Field 10 is checked.

FIELD 13: COMPANY STATE (RULE SECTION: § 1092.201(G)) Instructions

- *Information Type*: Identifying
- *Required*: Yes, if Field 10 is *not* checked
- *Instructions:* Select, from the list, the two-character abbreviation for the State or U.S. territory of the principal place of business for the registering nonbank.

Validations

- Only one State or U.S. territory may be selected.
- Will not appear if Field 10 is not checked.

FIELD 14: COMPANY ZIP/POSTAL CODE (RULE SECTION: § 1092.201(G)) Instructions

- Information Type: Identifying
- *Required*: Yes, if Field 10 is *not* checked
- *Instructions:* Enter, in the free form textbox, the 5- or 9-digit zip code of the principal place of business for the registering nonbank. Format should follow United States Postal Service requirements.

EXAMPLES: "10001" or "10001-1234"

- Must be a number (i.e., 1, 2, 3, etc.) or hyphen.

2.1.4 Company Unique Identifiers

The Company Unique Identifiers section requires the point of contact to submit all applicable unique identifiers obtained by or issued for the registering nonbank. If the registering nonbank has obtained or was issued any of the unique identifiers in the fields provided in the CFPB's NBR Portal, that information must be entered. At least Taxpayer ID Type must be selected to register the nonbank.

If, at any time after completing registration of the nonbank, a unique identifier is obtained or issued that was not submitted during the initial registration, a user with the appropriate portal permissions must log into the CFPB's NBR Portal and add the relevant unique identifiers (see

Section 2.4 for instructions on adding company information after initial account creation and registration).

Unique identifiers that have been submitted cannot be edited by users. If changes are required to previously submitted unique identifiers, an authorized user with the appropriate portal permissions must request changes through submission of a Support Ticket (see Section 2.6).

FIELD 15: LEI (RULE SECTION: § 1092.201(G))

Instructions

- Information Type: Identifying
- *Required*: Yes, if applicable
- *Instructions:* Enter, in the free form textbox, the 20-character alphanumeric Legal Entity Identifier (LEI) of the registering nonbank, if applicable. If a LEI has not been issued to the registering nonbank, leave this textbox blank.

Example: "10BX939C5543TQA1144M"

Validations

- Must be 0 or 20 characters in length.
- May contain any combination of uppercase and lowercase letters (i.e., A-Z and a-z) and numbers (i.e., 1, 2, 3, etc.).
- May not contain any spaces or special characters (e.g., hyphen, apostrophe).
- May be left blank (e.g., if not applicable).

FIELD 16: TAXPAYER ID TYPE (RULE SECTION: §§ 1092.201(A); 205(A)(2)) Instructions

- Information Type: Administrative
- *Required*: Yes
- *Instructions:* Select, from the list, the Taxpayer ID Type used for the registering nonbank. The options available are Employer Identification Number (EIN), Social Security Number (SSN), or Individual Taxpayer Identification Number (ITIN).

FIELD 16A: TAXPAYER ID NUMBER (RULE SECTION: §§ 1092.201(A); 205(A)(2)) Instructions

- *Information Type*: Administrative
- *Required*: Yes, if Employer Identification Number (EIN) was selected for Field 16
- Instructions: Enter, in the free form textbox, the Employer Identification Number (EIN)

of the registering nonbank, if applicable in the *##-######* format. Social Security Numbers (SSN) or Individual Taxpayer Identification Numbers (ITIN) must not be included.

- Must contain numbers (i.e., 1, 2, 3, etc.).

If the RSSD ID is less than 10 characters, enter leading zeros to provide a 10-character ID. If an RSSD ID has not been issued to the registering nonbank, leave this textbox blank.

EXAMPLE: If 1, enter "000000001"

- Must contain numbers (i.e., 1, 2, 3, etc.).
- May not contain any letters (i.e., A-Z and a-z), spaces, or special characters (e.g., hyphen, apostrophe).
- May be left blank (e.g., if not applicable).

FIELD 20: HMDA ID (RULE SECTION: § 1092.201(G))

- Information Type: Identifying
- *Required*: Yes, if applicable

Instructions: Enter, in the free form textbox, the 10- or 20-character alphanumeric HMDA ID assigned to the registering nonbank through the HMDA Platform, if applicable. If the HMDA ID is less than 10 characters, enter leading zeros to provide a 10-character ID. If HMDA ID has not been issued to the registering nonbank, leave this textbox blank.

EXAMPLE: If 1, enter "000000001"

2.1.5 Submission of the Initial Account Creation and Registration Information

Once all required fields are completed, the point of contact may click "Submit Registration" to submit the point of contact and company registration information to the CPFB's NBR Portal. There is no option to partially complete the form, save, and return at a later date. Refreshing or leaving the webpage before a submission is complete will erase any data entered prior to a completed submission.

If required fields for Company Point of Contact Information and Company Principal Place of Business Address Information are not completed, the user will receive an error message under the required field. If any fields for Company Unique Identifiers are incorrectly completed, the point of contact will receive an error message under the field. If no fields, other than Taxpayer ID Type, for Company Unique Identifiers are completed, the point of contact will receive an error message in a pop-up window. For example, if none of the company unique identifier fields are completed, the user will receive a "Company Unique Identifiers Validation Error" message. The point of contact must click "Cancel" and return to the submission form to complete at least one of the unique identifier fields if any are applicable. However, the point of contact may alternatively click "Ok" to confirm that the registering nonbank has not been issued any of the requested unique identifiers and return to the submission form to submit the registration.

Once submission is successfully completed, the user will receive an automated email from a CFPB email address that provides a link to log into the CFPB's NBR Portal (and to set a password, if applicable) (see Section 2.2, below).

The Nonbank Registry (NBR) is a system of record for the Consumer Financial Protection Bureau (CFPB or Bureau). Covered nonbanks use the NBR to register their company and submit a copy of certain final public orders or judgments.

Upon successful login to the CFPB's NBR Portal, a user will be automatically redirected to the CFPB's NBR Portal home page. From the home page, users can easily navigate to specific topic areas such as Company and User Management, Order Management, Notices to CFPB, as well as obtain guidance resources and support. Similar navigation is also provided in the tabs at the top of the page, permitting users to easily navigate between sections without having to return to the home page.

If a user account is associated with more than one registered nonbank, a button will appear towards the top center of the home page, under the company name, where the user can select "Switch Company" to switch to another company associated with the user's username.

Once clicked, a pop-up window will appear with the other registered nonbanks associated with that user profile, allowing the user to switch between nonbank registration home pages.

To have multiple nonbanks associated with a user profile, the user must use the same login username for profiles associated with each nonbank.

2.2.2 Password reset

If a user has forgotten their password, they may click the "Forgot Password" link. Doing so will open a pop-up window where the user may enter their username to receive an automated email with a password reset link. The username entered must be the username associated with the CFPB's NBR Portal user account.

Resetting a password will delete the password recorded in the CFPB's NBR Portal and will require the user to set a new password (from the link included in the automated email) in order to log into the CFPB's NBR Portal. Clicking "Cancel" in the password reset pop-up window will return the user to the CFPB's NBR Portal log-in screen without requesting a password reset (or deleting the password associated with the account).

After clicking "Reset Password" the "Now check your email" message will display in the pop-up window. If the username entered is associated with an NBR user account, an automated email is sent to the user explaining how to reset the password. The email will provide a hyperlink to the CFPB's NBR Portal's "Reset your password?" page. The user must click the "Reset Password" button on this page and enter the new password in both the "New Password" and "Confirm New Password" textboxes. The password must meet the following criteria:

- 1. Must be at least 12 characters in length;
- 2. Must include at least one letter and at least one number;
- 3. Must not include any spaces;
- 4. Must require an entry in both of the two textboxes;
- 5. Must require that the password entered in both textboxes match; and

6. May be any combination of uppercase and/or lowercase letters (i.e., A-Z and a-z), numbers (i.e., 1, 2, 3, etc.), and special characters (e.g., hyphen, apostrophe).

Once completed, the user must click "Change Password" to finish resetting the password.

If the username entered in the password reset pop-up window is not associated with a user account in the CFPB's NBR Portal, an automated email is not sent.

Users that continue to have difficulty logging in or resetting their password after following the instructions above (for example because they forgot their CFPB's NBR Portal login username) may contact the CFPB by emailing <u>NBRHelp@cfpb.gov</u> to create a Support Ticket.

2.3 User Management tab

The User Management tab is where a registered nonbank's user with the appropriate <u>portal</u> <u>permissions</u> may create new user accounts and manage another user's portal permissions. Instructions for these tasks are discussed below.

2.3.1 Manage Company Users table

All users can see their own user information on the "Manage Company Users" table. Points of contact or users with Manage Company User permissions will see all user accounts associated with a registered nonbank in the "Manage Company Users" table, which is accessible through the User Management tab of the CFPB's NBR Portal. The Manage Company Users table is where a registered nonbank's user with the appropriate portal permissions may create new users and manage (i.e., edit) another user's portal permissions within the CFPB's NBR Portal.

The Manage Company Users table provides a detailed view of the nonbank's users including the user's First Name, Last Name, Email, and Username. The table also includes the user's access permission details to Company Information, Order Management, and whether or not the user is a Point of Contact, has Manage Company User permissions, and has Active status for the nonbank in the CFPB's NBR Portal.

2.3.2 User creation

Once an initial user account is created for a registered nonbank, that initial user will by default have all portal permissions available to users. As such, the initial user will be able to create and manage additional users to be associated with the registered nonbank.

To create a new user, navigate from the CFPB's NBR Portal home page to the User Management tab. Once there, do the following:

- 1. Click on the "+ Create User" button;
- 2. Enter the User Details;
- 3. Select the appropriate Portal Permissions; and
- 4. Click the "Save" button.

Upon creation, users have default permissions (see Section 2.3.2) to view and edit fields within the CFPB's NBR Portal for the registered nonbank.

The User Details fields for user creation include the user's first name, last name, and email address, although only a last name and email address are required to create a user account. This information is considered administrative information under the regulation.

Each user account associated with the registered nonbank must have its own distinct email address for that registered nonbank. The CFPB's NBR Portal does not permit multiple user accounts for a registered nonbank to share the same email address. For example, Company Nonbank, Inc., cannot identify the email address "admin@nonbank.com" as the email address for both Person A's and Person B's user account. Each Company Nonbank, Inc., user account must have a different email address. The CFPB's NBR Portal will always associate the provided registered email address with the first and last name provided during account creation (or those provided to the account during updates).

However, because a user account can be associated with multiple registered nonbanks, that user can use the same email address for each account. The CFPB's NBR Portal will auto correct the first name and last name fields for any additional accounts added with that email address to the first name and last name field entries submitted for the original account set-up for the email address. For example, if Person A has a user account for Company Nonbank, Inc., and Entity Nonbank, LLC, Person A's email address (admin@nonbank.com) can be the same for both of Person A's user accounts.

Portal permissions determine what information a user is authorized to view or change for other user accounts, for orders registered, and for company information submitted. Portal permissions are initially pre-selected with "Active" status and the lowest permissions available (no Company Information Access, no Order Management Access, no Manage Company User permissions, and no designation as a Company Point of Contact). Portal permissions may be edited from the pre-selected values by a registered nonbank's user with Manage Company User or Company Point of Contact permissions. A user may not deactivate, reactivate, or change any of their own portal permissions.

The following are the available portal permissions and what they authorize within the CFPB's

NBR Portal when selected:

- Active Status: A checkmark in the checkbox means the user's account is active and the user has the portal permissions for the registered nonbank as indicated on their user account. No checkmark means the user's account is inactive. Inactive users are not able to access the CFPB's NBR Portal. Active status is preselected upon user creation.
- **Company Information Access:** A user's Company Information Access permission may be set at 1) Read or 2) Edit.
 - Read access means 1) the user has access to the Company Info tab, 2) the user can view the Company Information data fields and 3) the user can view the Notices to CFPB. All users must have Read access.
 - Edit access provides the same portal permissions as Read access, but also means 1) the user can edit the Company Information data fields and 2) the user can create and submit new Notices to the CFPB. A user designated as a Company Point of Contact must have Edit access.

Read access is the default permission preselected upon user creation.

- Order Management Access: A user's Order Management Access may be set at 1) No Order Access, 2) Read, or 3) Create/Edit.
 - No Order Access means 1) if the user selects the Order Management tab, the webpage presents the following message, "Please contact your company's Nonbank Registration Point of Contact if you believe you should have access to this page", 2) the user will not be able to view, create, edit, and/or submit any Order, and 3) the user will not be able to view, create, and/or submit an Annual Statement Filing or Final Statement Filing on any Order.
 - Read means 1) the user has access to the Order Management tab, 2) the user can view any data fields or documents related to all draft and submitted Orders, and 3) the user can view all Annual Statement Filings or Final Statement Filing related to any Order.
 - Create/Edit means 1) the user can create, edit, and/or submit any data fields or upload documents related to all draft and submitted Orders and 2) the user can create and submit an Annual Statement Filing or Final Statement Filing related to any Order.

No Order Access is the default permission preselected upon user creation.

• Manage Company Users: A checkmark in the checkbox means 1) the user has access

to the User Management tab and 2) the user can view all users, create new users, and assign/edit other users' portal permissions. No checkmark in the checkbox means 1) the user has access to the User Management tab and 2) the user cannot view, create, or edit other users' account information for the registered nonbank. Manage Company Users permission is not provided by default to new users upon creation with the exception of the user that completes the initial account creation and registration. A user designated as a Company Point of Contact must have Manage Company Users permission.

• **Company Point of Contact:** A checkmark means 1) the user is a company point of contact, 2) the user must have Edit for Company Access, 3) the user must have Create/Edit for Order Management Access, 4) and the user must have a checkmark for Management Company Users. No checkmark in the checkbox means the user is not the company point of contact. There is no limit to the number of user accounts that can be designated as a point of contact for a registered nonbank. Company Point of Contact is not selected by default for new users upon creation, with the exception of the user that completes the initial registration for the nonbank.

Once the appropriate portal permissions are selected for the user, clicking "Save" will finish creating the new user account or editing the existing users' portal permissions for the CFPB's NBR Portal.

2.3.3 Editing existing user information

To edit an existing user's portal permissions:

- 1) Identify the relevant user in the Managing Company Users table;
- 2) Click on the pencil icon for that row to enter edit mode;
- 3) Select the appropriate fields to edit; and
- 4) Click the "Save" button.

No users can edit their own portal permissions. A Company Point of Contact or user with Manage Company User permissions may edit another user's portal permissions. If a user wants to change their portal permissions, the user should contact their Company Point of Contact. A user's first name, last name, email address, and username may only be changed by the CFPB (i.e., by creating a Support Ticket in the CFPB's NBR Portal or emailing NBRHelp@cfpb.gov).

2.4 Company Info tab

On the Company Info tab, users with the appropriate portal permissions, can view and edit company information submitted upon initial registration (see Section 2.1). The tab provides the

same fields of information as those discussed in Sections 2.1.2 through 2.1.4 and includes additional fields where a user with the appropriate portal permissions may enter the mailing address of the nonbank. Additionally, the tab includes a section at the bottom of the page for Notices to CFPB, which contains all Good-Faith Notices submitted by the nonbank and is the starting point to submit new Good-Faith Notices.

Company information is pre-populated based on the information provided at initial account creation and registration. If changes are required, a user with the appropriate portal permissions (see Section 2.3.2) must click the pencil icon () to edit a field and submit a

change. For example, if the nonbank's principal place of business changes after the initial registration, an authorized user with the appropriate portal permissions may select the pencil icon and input the new address information using the same instructions provided in Section 2.1.3. As discussed in the <u>Nonbank Registration of Orders Final Rule Executive Summary</u>, revisions must be made within 90 days of the date of the change.

Unique identifiers that have been submitted cannot be edited by users. If changes are required to previously submitted unique identifiers, an authorized user with the appropriate portal permissions must request changes through submission of a Support Ticket or by emailing NBRHelp@cfpb.gov (see Section 2.6). However, unique identifiers previously left blank can be added by users with the appropriate portal permissions.

2.4.2 Good-Faith Notices to CFPB

Under the Company Info tab, a user may review, edit, and submit Notices to the CFPB. Notices to the CFPB are the Notices of Good-Faith Non-Registration (Good-Faith Notices). More information about Good-Faith Notices can be

The table provides the following information:

- **NBR Assigned ID**: This field returns the Notice's NBR Assigned ID, as assigned by the system.
- **Submitted Date**: This field identifies the date the notice was submitted to the CFPB.
- **Submitter Name**: This field identifies the name of the user who submitted the notice on behalf of the registered nonbank.
- **Explanation**: This field returns the Additional Information as entered by the user who submitted the notice.
- View Notice: Clicking this button returns a pop-up that displays the data entered by the nonbank's user including any documents uploaded with the filing. The Order Management tab is where a registered covered nonbank's (herein, nonbank or company) user with the appropriate portal permissions may view, create, edit, and/or submit the registration for a covered order(s). Company Points of Contact and users with Order Management Access "read" or "create/edit" portal permissions may view the orders on this tab. A user with the Order Management Access that is Create/Edit or with Company Point of Contact portal permissions may also export orders from the Order Management tab. Exporting orders provides the user with a Microsoft Excel .csv file with comma-separated values providing several data fields (as entered by the registered nonbank) for each order.

The Order Management tab consists of two tables, the Draft Orders table and the Orders Submitted to CFPB table. The Draft Orders table provides a list view of Order Registrations that have been created and saved but not yet submitted to the CFPB, as well as Order Registrations previously submitted to the CFPB but returned. The Orders Submitted to the CFPB table provides a list view of Order Registrations that have been completed and submitted to the CFPB. Both tables include the following information:

- NBR Assigned ID: Nonbank Registry (CFPB's NBR Portal) assigned identification number.
- Identifying #: Provides the Order's identifying number.
- Attesting Executive: Provides the name of the attesting executive for the order (applicable if the nonbank is a CFPB-Supervised Covered Nonbank).
- NMLS-published indicator: Identifies whether the order is published on the NMLS Consumer Access webpage.

• Status: Identifies the order's registration status.

For the Draft Orders table, available statuses include:

- Draft status An order that has not yet been submitted to the CFPB.
- Returned status An order that was submitted to the CFPB but returned and repopulated in the Draft Orders table. Users receive an email with the reason for return of the order and instructions on next steps to resubmit the order, if applicable.

For the Orders Submitted to the CFPB table, available statuses include:

□ Submitted to CFPB status – An order that was successfully submitted to the CFPB.

Both tables also contain the ability to either edit or delete draft submissions or view completed submissions.

On the Draft Orders table:

- Clicking the "Edit" button will allow an authorized user with the appropriate portal permissions to edit a draft order submission, as discussed in 5.5.1.
- Clicking the delete button (i.e., ind icon) will permit an authorized user with appropriate portal permissions to delete a draft order submission.

On the Orders Submitted to the CFPB table:

- Clicking the "View" button will allow an authorized user with the appropriate portal
 permissions to review details of the order submission and to complete Annual and Final
 Statement Filings for the order. The button will navigate authorized users to the Related
 Annual Statement Filings and Related Final Statement Filings tables.
 - After clicking the "View" button, a user may click the "Revise Order" button which will allow a user with appropriate portal permissions to edit any data fields, delete any uploaded file(s), and/or upload additional files for a completed order.

- Attesting Year: This field identifies the year for which the annual filing covers.
- Attesting Executive: This field identifies the first and last name of the attesting executive for the filing.

Registered nonbanks with more than five orders in each of these respective tables will have more than one table page for the applicable table. To navigate to other table pages, use the "First," "Previous Page," "Next Page," and "Last" buttons at the bottom left-hand corner of the table.

This section discusses the required fields for registrations summarized in these tables and the process steps required for submission to the CFPB's NBR Portal for covered orders, NMLS-published orders, Annual Filings, and Final Filings. More information about these

requirements can be found in the <u>Nonbank Registration of Orders Final Rule Executive</u> <u>Summary</u>.

2.5.1 Order Registration Processes

The Order Management tab is where a registered covered nonbank completes the process to register an order with the CFPB's NBR Portal. The following are the process instructions for completing order registration, including editing draft registrations and previously submitted registrations.

Creating a new order registration

The "+ New Order" button in the upper right-hand corner of the Draft Orders table will allow a registered nonbank's user with the appropriate portal permissions to create a new order registration.

To create a new registration for a covered Order:

- 1. Click the "+ New Order" button;
- 2. Click the "Proceed" button;

3. Click the radio button to select "My company is registering this covered order with the CFPB Nonbank Registry under 12 CFR 1092.202;"

- 4. Click the "Next" button;
- 5. Complete all applicable fields (see Section 2.5.2);

6. Upload fully executed, accurate, and complete copy of the Order, including any amendments and/or modifications to the Order; and

7. Click the "Save & Submit" button.

Some fields are required, some fields are required when applicable, and some fields are optional. Required fields are indicated by a "*" next to the field name. If the user is not ready to submit the Order registration to the CFPB, the user may select the "Save & Exit" button to save the information and any documents uploaded.

Editing a draft order registration

To return to, or edit, a draft registration for a covered Order:

1. Click on the Order Management tab;

2. Locate the draft Order on the Draft Orders table;

3. Click the "Edit Draft" button on the right-hand side of the order's row;

4. Review and, if applicable, revise any selections and information previously submitted (see Section 2.5.2);

5. Upload any applicable documents (i.e., any amendments and/or modifications to the Order); and

6. Click the "Save & Submit" button.

If the user is not ready to submit the order to the CFPB, the user may select the "Save & Exit" button to save the information and any documents uploaded.

Submitting revisions to a completed order registration

If, at any time after submitting a covered order to the CFPB's NBR Portal, the order information changes or is amended and/or modified, a registered nonbank user with the appropriate portal permissions may edit the order information and upload additional order documents within the required timeframe.

To edit the registration for a previously submitted covered order:

- 1. Click on the Order Management tab;
- 2. Locate the Order on the Orders Submitted to CFPB table;
- 3. Click the "View" button for the Order;
- 4. Click the "Revise Order" button;

5. Review and, if applicable, revise the previous selection(s) and information previously submitted (see Section 2.5.2); and

6. Click the "Submit Updates" button.

2.5.2 Order Fields

Prior to creating a new order registration, the registered covered nonbank is presented a page of information that includes guidance for determining whether the order is a "covered order." To proceed Only users with Company Point of Contact permissions or Create/Edit Order Management Access permissions can complete the required order fields.

with registration, the registered covered nonbank must select the "Proceed" button.



As discussed, to submit an order, or edit an order registration at any stage, the registered covered nonbank must complete or review certain fields for the order.

First, a covered nonbank must identify the order being registered as a registration for a Covered Order or as an NMLS-published covered order (as discussed in Section 2.5.3). **This section discusses the fields for covered orders.**

For any covered Order that: 1) is published on the NMLS Consumer Access website and 2) not issued or obtained by the CFPB, the company may select the one-time registration notice option below. Not sure if this covered order qualifies? For more information on optional one-time registration of an NMLS-published covered order review the Executive Summary of the Nonbank Registration of Orders Rule. To determine whether you have an NMLS-covered order(s) (final order published by a state agency through NMLS), log into your NMLS account or view on the NMLS Consumer Access website. You can also visit the CFPB's Nonbank Registry public page for general information. How would you like to proceed with registering this covered order? My company is registering this covered order with the CFPB Nonbank Registry under 12 CFR 1092.202. My company is selecting the option to submit a one-time registration for this NML5-published covered order (final order published by a state agency through NMLS) under 12 CFR 1092.203. 2.6 Support tab

Users can request regulatory guidance or technical support from the CFPB if they have a question but are unable to find the answer in the resources provided by the CFPB. Requests for support can be made by:

• Submitting a Support Ticket within the CFPB's NBR Portal: A user that is logged into the

CFPB's NBR Portal may request assistance from the CFPB by selecting the Support tab at the top of the CFPB's NBR Portal and submitting a Support Ticket. The Subject and Describe the Issue textboxes are required. After clicking "Submit" a pop-up window will appear where up to 10 PDF files may be uploaded with the submission.

• *Submitting an email request:* If there is no access to the CFPB's NBR Portal, a person may request assistance by emailing <u>NBRHelp@cfpb.gov</u>. The email should contain the question, as well as contact information so that the CFPB may respond to the inquiry.

The Support Tickets table includes:

- **NBR Assigned ID**: This field identifies the Support Ticket's NBR Assigned ID, as assigned by the system.
- **Company**: This field return the company name under which the user submitted the Support Ticket.
- **User**: This field returns the name of the user who submitted the Support Ticket.
- **Subject**: this field returns the Subject as entered by the user who submitted the Support Ticket.
- **View**: Users can view the description of the issue as entered by the Support Ticket filer and/or any file(s) uploaded with the Support Ticket, by clicking the "View" button on the Support Tickets table. Clicking this button returns a pop-up that displays the data entered by the nonbank's user. Clicking the "View File" button within that pop-up window will open the document in a new browser tab. Note: The file preview links may take up to a minute to load depending on file size and internet speed.
This information is administrative information.

Each user has access to a Support Ticket table that contains tickets for all registered nonbanks associated to their profile so the user may view and access tickets without requiring the user to switch profiles. Users with more than five tickets will have more than one table page. To navigate to other table pages, use the "First," "Previous Page," "Next Page," and "Last" buttons at the bottom left-hand corner of the table.

CFPB's response to a Support Ticket is sent via email to the email address on the user's account in the CFPB NBR Portal. CFPB responses are not accessible or viewable through the CFPB's NBR Portal.
